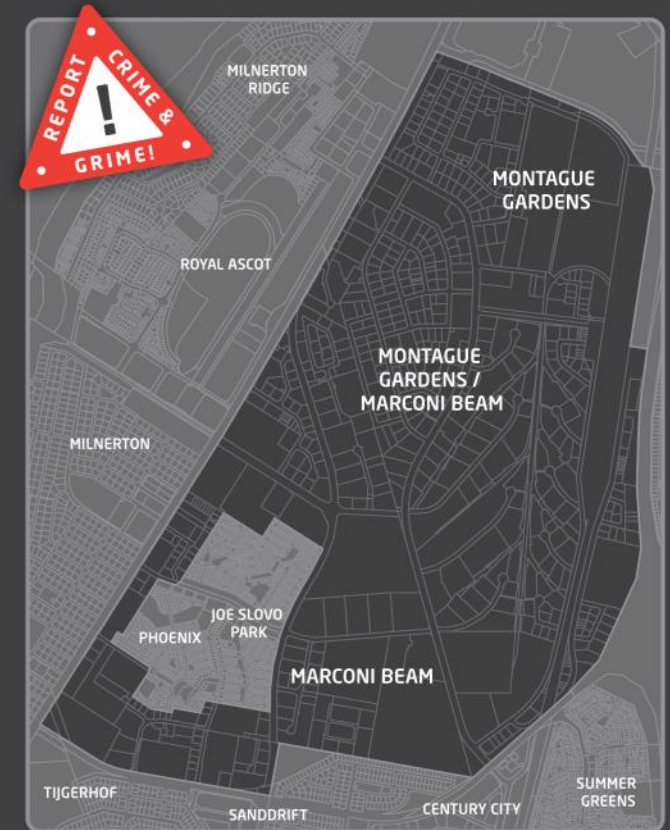
As a City Improvement District (CID) established in terms of Section 22 of the Municipal Property Rates Act (MPRA), the Municipal Finance Management Act (MFMA), Section 21 of the Companies Act, the SA Constitution and Cape Town’s City Improvement District By-Law of 2004, the MMID focuses on:

- Improving safety and security
- Enhancing and supplementing municipal services
- Facilitating investment
- Facilitating a co-operative approach between the City and the private sector
- Enabling the upliftment of the Montague Gardens-Marconi Beam area
- Promoting economic growth and sustainable development

PUBLIC SAFETY

The MMID has been established to provide top-up security services (in collaboration with existing role players), mobilise joint safety operations, monitor trends and act as a visible presence. These services do not replace those provided by SAPS, Law Enforcement and the Metro Police.

Together with the relevant role players, the MMID has developed a comprehensive and integrated Public Safety Plan which includes:

› SECURITY PATROLS

The MMID has outsourced the public safety security service to Star Rapid Response, which is registered with the Private Security Regulatory Authority (PSIRA). The appointment was based on a competitive selection process and service level agreement. The three-year contract will be renewed annually based on performance and adherence to the service level agreement. Three vehicles patrol the MMID 24 hours a day, seven days a week.

› CCTV CAMERA SURVEILLANCE

Patrol vehicles will be backed up and guided to potential security threats or incidents by trained CCTV controllers who will monitor a network of cameras positioned in strategic public areas around Montague Gardens and Marconi Beam. Security Control and CCTV Surveillance will be conducted from a security industry-approved control room which will be staffed 24 hours a day, seven days a week. CCTV controllers will work closely with public safety officers.

› LAW ENFORCEMENT OFFICERS

A permanent Law Enforcement Officer with full powers of arrest has been contracted to the MMID by the City of Cape Town to work alongside the public safety officers supplied by the security provider. The officer will also monitor and enforce By Law transgressions such as illegal dumping.

› CO-OPERATING WITH SAPS, LAW ENFORCEMENT AND THE METRO POLICE

CLEANING

As part of its commitment to keeping the Montague Gardens and Marconi Beam area clean, the MMID provides top-up cleaning services in addition to those provided by the City of Cape Town.

A full-time cleaning team outsourced to Vizual Multi Services Group, consisting of a cleaning and maintenance supervisor and four general workers, is responsible for the following:

- Managing litter
- Street sweeping
- Illegal dumping

- Bush clearing
- Reporting environmental threats to public health and safety
- Maintaining formal and informal green areas within the MMID
- Reporting regularly to the MMID manager

As part of the cleaning strategic programme the MMID employs workers, preferably homeless or unemployed people, on an ad hoc basis. Major clean-up projects are conducted in the area where necessary.

URBAN MANAGEMENT

The MMID has a key role to play in terms of urban management and monitors signage, traffic, drains, railings, street lights, storm water gullies and more. It also covers the cost of services and infrastructure, which are the responsibility of the City, where the City is unable to provide them to the required standard of the property owners.

The MMID will provide support by:

- Identifying infrastructure, maintenance and development projects and developing project plans for them
- The monitoring of and reporting on public infrastructure and maintenance issues - broken street signs, blocked drains, broken streetlights, missing drain covers etc.
- Appointing contractors for development and maintenance projects
- Liaising with local authorities regarding road maintenance, illegal signage etc. to ensure that these services are provided by the City as well as other service providers
- Providing top-up additional municipal services on an ongoing basis, as identified in the perception survey and business plan
- Monitoring and reporting on environmental and noise pollution offenders
- Encouraging recycling and promoting waste minimisation through education and awareness on waste and water pollution
- Making minor repairs where necessary
- Developing and implementing a greening plan
- Co-ordinating actions with City of Cape Town departments
- Logging C3 notifications and following up on them

SOCIAL DEVELOPMENT

Social development programmes play a key role in providing social economic upliftment in an area. The MMID liaises with local NGOs and the City's Department of Social Development (DSD) to, where possible:

- Help reduce vagrancy in the area and facilitate the rehabilitation of vagrants
- Provide work opportunities for homeless and unemployed people
- Provide skills development opportunities
